Information about repatriation for refugees and
immigrants

ARE YOU THINKING ABOUT RETURNING TO YOUR HOME COUNTRY?

Danish Refugee Council offers counselling for refugees and immigrants who are thinking about returning to their home country. We are working to find sustainable solutions to the refugee crisis in Denmark and around the world.

REPATRIATION BENEFITS

- In 2019 adults receive cash amount of max. **139.274** DKK to establish in the home country
- Minors receive cash amount of max. **42.476** DKK

The cash amount is paid in two instalments – first instalment at the departure and after one year in the home country **83.565** DKK per adult and **25.486** DKK per child

OTHER BENEFITS

- Travel expenses
- Freight costs or cash amount to buy new furniture and personal effects
- Purchase of business equipment
- Health insurance coverage for 4 years
- Prescribed medicine for a 1-year period
- Needed personal medical devices
- Expenditure for schooling for 4 years for children between 5-16 years of age
- Expenses related to the acquisition of passports/travel documents

PERSONS ABOVE THE AGE OF 55

Are you above 55 years of age you may be granted a monthly reintegration allowance from Denmark.

The monthly amount of the reintegration allowance is between 2.800 DKK and 5.500 DKK. To receive the monthly integration allowance, you must have had residence permit in Denmark for a minimum period of 5 years

THE RIGHT TO RETURN TO DENMARK

Refugees are rightfully able to return to Denmark within a year after returning to their home country. This means that they may be able to re-obtain their rights in Denmark. Making use of the right to return to Denmark involves paying back the full amount of the granted repatriation benefits.

Immigrants are not able to return to Denmark or to re-obtain their rights after returning to their home country. For immigrants, the decision of returning to the home country is final which also means giving up all rights related to the residence in Denmark.
